NEWBILL, BEING FIRST DULY SWORN, DEPOSE AND SAY: THAT I CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS AS INDICATED ON THE ACCOMPANYING PLAT OF McDEVITT ADDITION #5 TO THE TOWN OF PILOT ROCK LOCATED IN UMATILLA COUNTY OREGON THE LANDS INDICATED THEREON; THAT TO INDICATE THE INITIAL POINT I PLACED A 3" GALV. IRON PIPE 36" LONG 6" BELOW GRADE AND AS SHOWN ON THE PLAT AT THE NORTHWEST CORNER OF THE PROPERTY, THAT SAID POINT IS LOCATED SOUTH 14°51' WEST 2204.04 FEET FROM THE EAST QUARTER CORNER OF SECTION 17, TOWNSHIP 1 SOUTH, RANGE 32 EAST W.M. WHICH IS A KNOWN CORNER ESTABLISHED BY THE UNITED STATES SURVEY; THAT THE EXTERIOR BOUNDARIES OF THE TRACT OF LAND UPON WHICH SAID LOTS AND BLOCKS ARE LAID OUT ARE AS FOLLOWS: BEGINNING AT A POINT WHICH IS SOUTH 14°51' WEST A DISTANCE OF 2204.04 FEET FROM THE EAST 1/4 CORNER OF SEC. 17, T1S, R. 32 E.W.M., SAID POINT BEING THE SOUTHWEST CORNER OF McDEVITT ADD. #4 TO THE TOWN OF PILOT ROCK OREGON, AND RUN THENCE SOUTH 13° 09' EAST 532.25 FEET TO A POINT IN THE SOUTH LINE OF SAID SECTION 17; THENCE SOUTH 89°55' EAST ALONG SAID SOUTH LINE A DISTANCE OF 308.39 FEET, THENCE NORTH 10°45' WEST 113.56 FEET TO THE SOUTHWEST CORNER OF McDEVITT ADD. #2 TO THE TOWN OF PILOT ROCK OREGON;

THENCE ALONG THE WESTERLY LINE OF SAID McDEVITT ADD. #2 NORTH 13°09' WEST A DISTANCE OF 489.12 FEET TO THE NORTHWEST CORNER OF LOT 1 BLOCK "B" OF SAID McDEVITT ADD. #2 THENCE SOUTH 76°51' WEST 304.97 FEET TO THE POINT OF BEGINNING. THAT I INSCRIBED MY REGISTRATION NUMBER ON EVERY MONUMENT MARKING EVERY CORNER THAT I ESTABLISHED OR RE-ESTABLISHED ON SAID LAND AND AS SHOWN ON SAID PLAT; AND THAT THE SURVEY AND ALL MARKINGS HAVE BEEN DONE AS REQUIRED BY LAW.

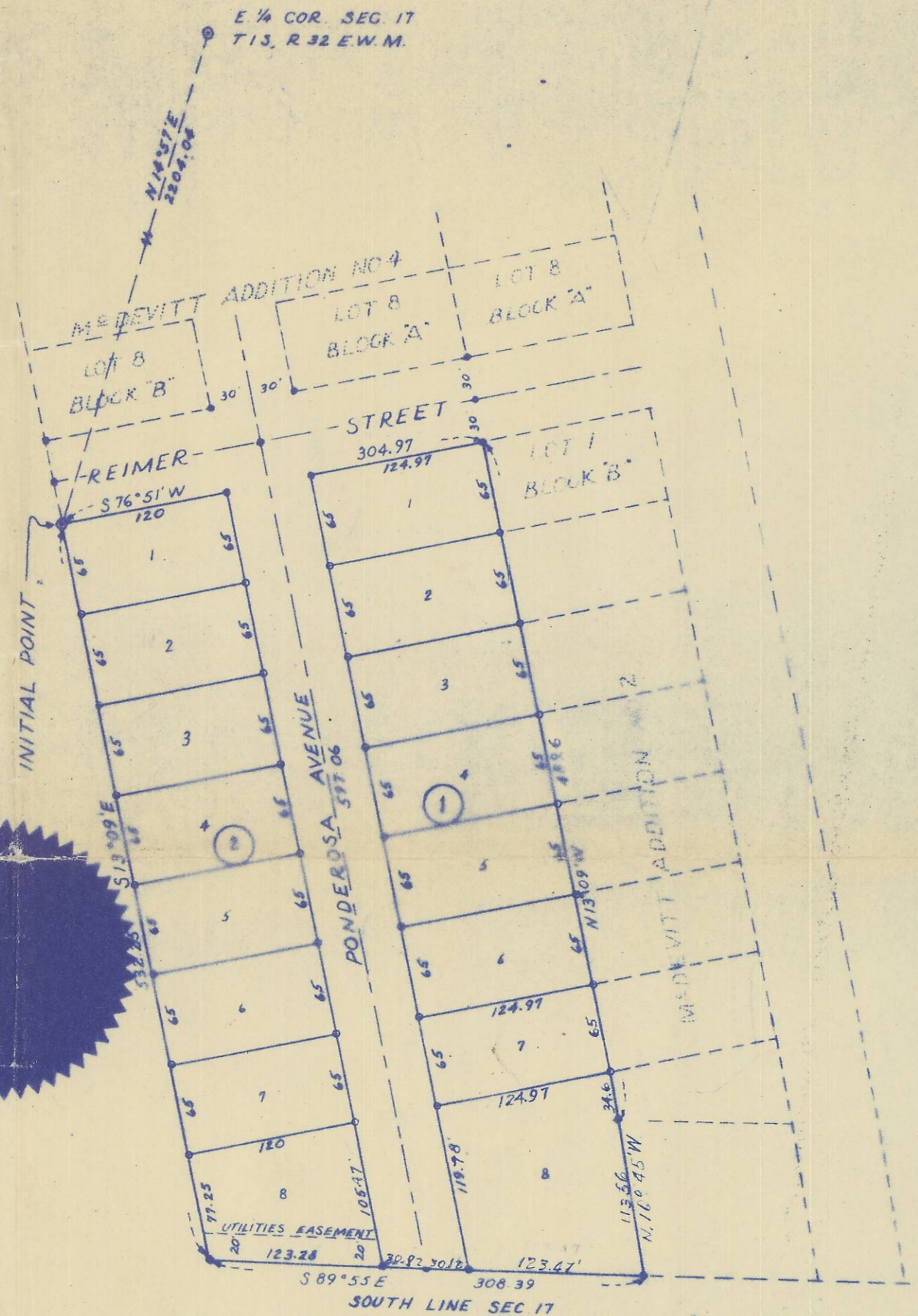
