

NARRATIVE:

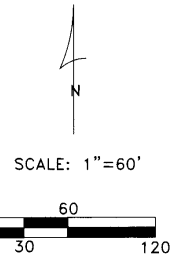
THE PURPOSE OF THIS SURVEY IS TO STAKE AN APPROXIMATELY 10,000 SQUARE FOOT PARCEL ON WHICH THE CATHOLIC CHURCH CAN LOCATE A YOUTH SERVICES BUILDING.

SAID PARCEL IS PART OF THAT TRACT OF LAND DEEDED TO THE ROMAN CATHOLIC BISHOP OF THE DIOCESE OF BAKER RECORDED ON REEL 353, PAGE 681, UMATILLA COUNTY DEED RECORDS. THE REMAINING APPROXIMATELY 2.50 ACRES IS TO BE COMBINED WITH PARCEL 3 OF PARTITION PLAT 1993-19 (TAX LOT 4418 OF MAP 4N 28 B).

I BASED THE BEARINGS ON MY PARTITION PLAT 1993-19. I DID NOT SURVEY THE REMAINING APPROXIMATELY 2.50 ACRES. I SURVEYED THE RAILROAD RIGHT OF WAY NORTH OF THE 10,000+ SQUARE FOOT PARCEL AND COMPUTED ITS APPROXIMATE LOCATION WEST OF THERE FROM THE PLAT OF "LAIRD ADDITION" WHICH SHOWED SAID RIGHT OF WAY.

THE EAST LINE OF BOTH PARCELS WERE STAKED AND DESCRIBED LEAVING A 5 FOOT STRIP WHICH IS TO BE DEEDED TO THE CITY OF HERMISTON TO BRING THE HALF WIDTH OF HINKLE ROAD UP TO CITY STANDARDS.
