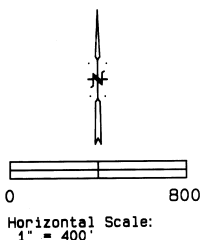


**SURVEY FOR

IN UMATILLA COUNTY, OREGON**



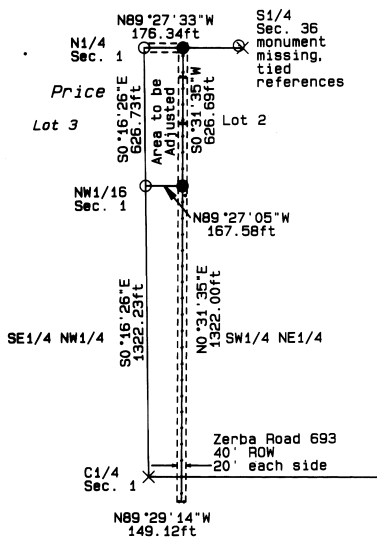
LEGEND:

BASIS OF BEARING

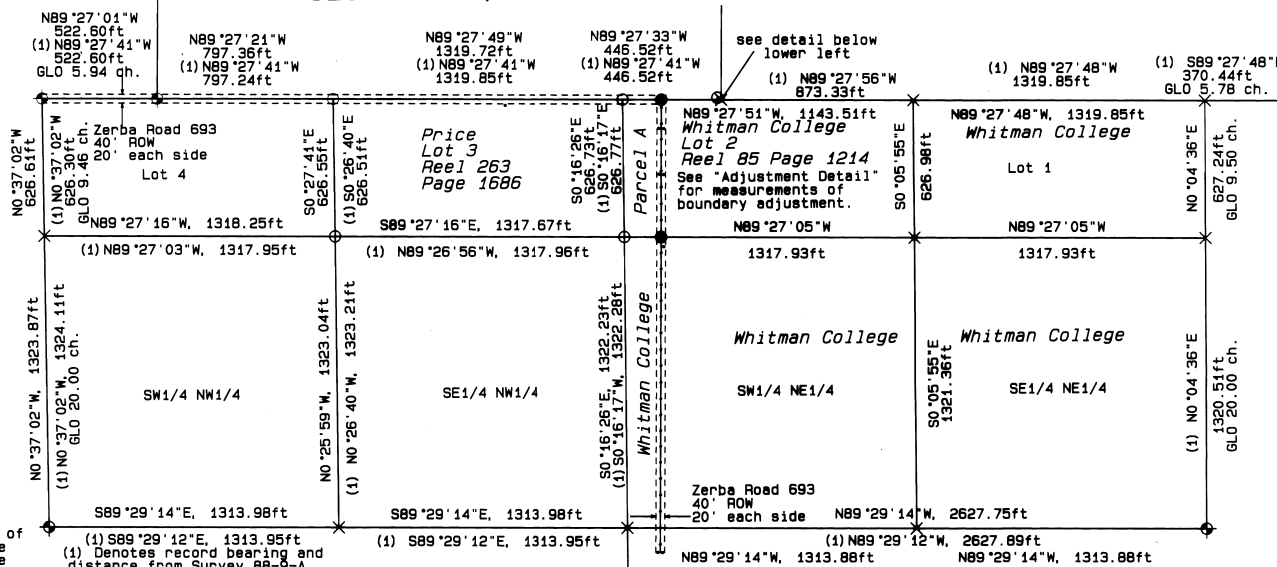
The survey was done with a Leica GPS System 200. The measurement along the west line of the NW1/4 of Section 1 was rotated 0°34'20" clockwise to agree with record survey 88-9-A. The GPS distances were multiplied by 1.0012753713 to develop the comparison to the weighted measurements from Survey 88-9-A.



DESCRIPTION OF PARCEL A TO BE BOUNDARY ADJUSTED

A parcel of land lying in Lot 2 of Section 1, Township 4 North, Range 34 East, Willamette Meridian, further described as follows: Beginning at the 5/8" iron rebar monumenting the Northwest corner of said Lot 2, (also being the north 1/4 corner of said Section 1); thence along the north to south centerline of said Section 1, S0°16'26"E, 626.73 feet to the 5/8" iron rebar monumenting the south east corner of said Lot 2; thence along the east to west centerline of the NE1/4 of said Section 1, S89°27'05"E, 167.59 feet to a 5/8" rebar in the centerline of Zerba Road, Umatilla County Road 693; thence along said road centerline, N0°31'35"E, 626.69 feet to a 5/8" iron rebar on said centerline and on the north line of said Section 1; thence along said road centerline and said Section line to the point of beginning, N89°27'33"W, 176.34 feet; containing 2.47 acres. This property is subject to rights of Umatilla County in County Road 693 and utilities presently located along that road.

NARRATIVE

The purpose of this survey was to adjust the east boundary line of the property of Fred David and Judith A. Price (Reel 263, Page 1686) and Whitman College (Reel 85, Page 1215) from the east line of government Lot 1 to the centerline of Zerba Road, a Umatilla County Road. The boundaries of the lands in Section 1, T. 4 N., R. 34 E., W. M. were established from the found monuments set by record survey 88-9-A. The monument of survey 88-9-A not found was the southeast corner of Section 36, T. 5 N., R. 34 E. This point was computed based on a reference monument and record distances from Survey 88-9-A, the northeast corner of Section 1 and the southeast corner of Section 36 were computed from record survey 88-9-A. The survey was done with a Leica GPS System 200.
