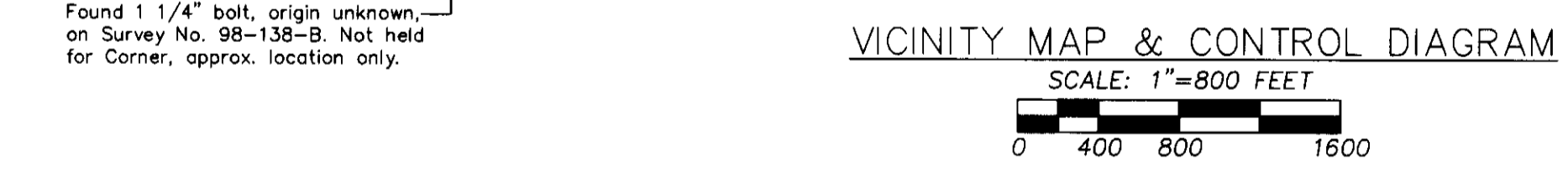
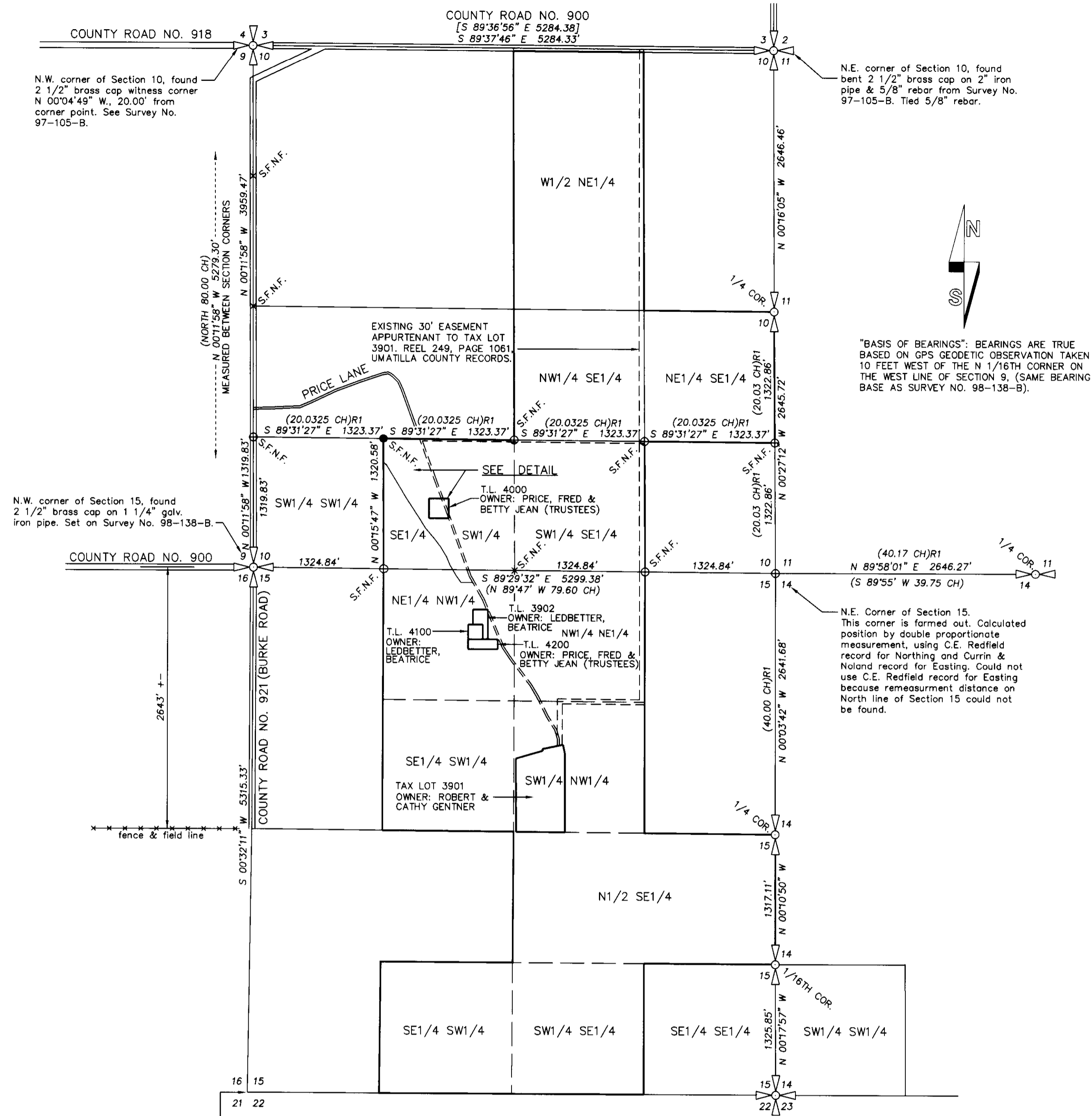


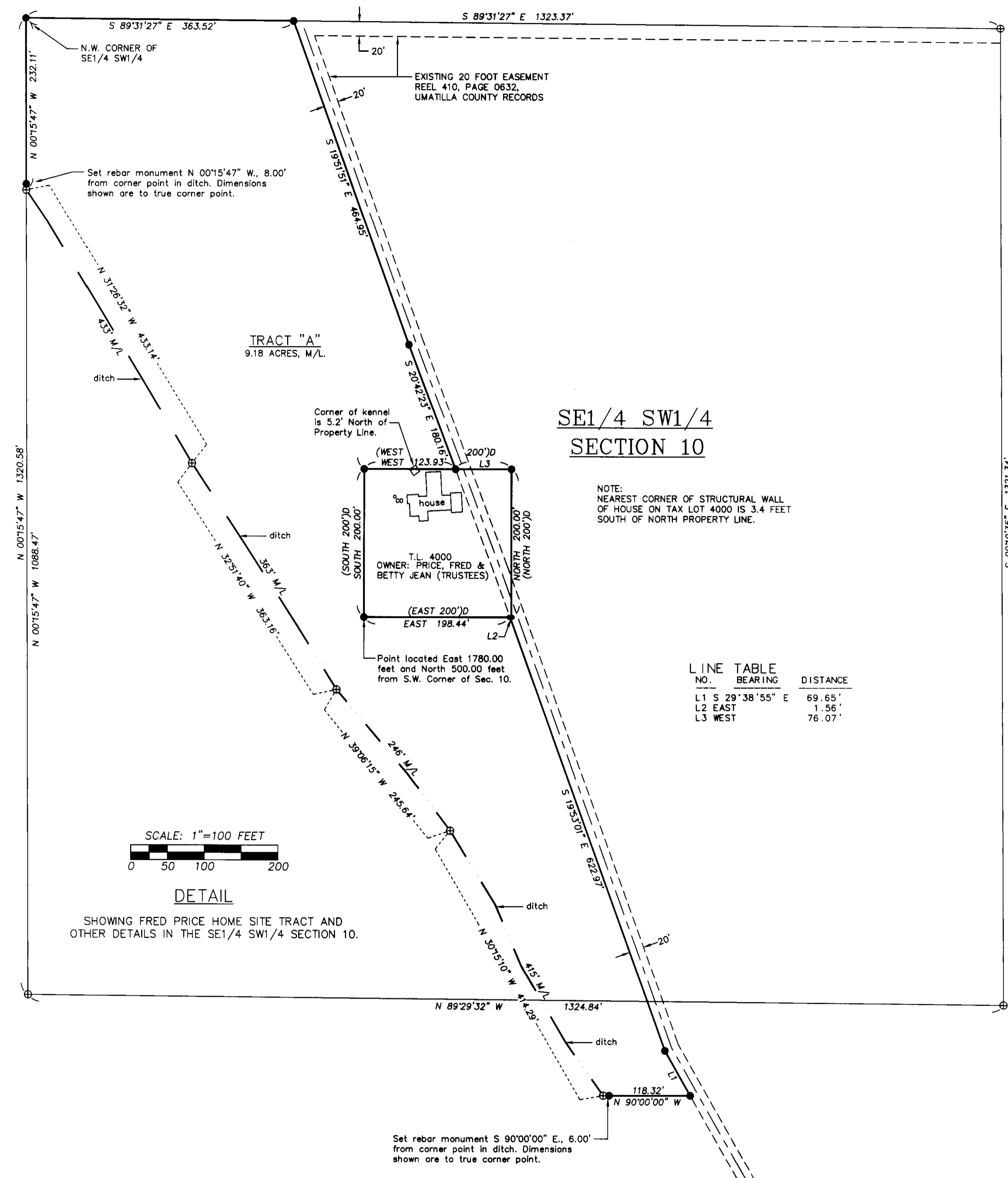
RECORD OF SURVEY

NARRATIVE

THIS SURVEY WAS MADE FOR THE PURPOSE OF LOCATING THE BOUNDARIES OF THE FRED PRICE HOME SITE AND A CERTAIN AREA WITHIN THE SE 1/4 SW 1/4 OF SECTION 10 LOCATED NEAR THE HOME SITE.

THE SURVEY WAS MADE WITH A 2 PERSON CREW USING A LEICA 399 GEODETIC GPS SYSTEM OPERATED IN REAL TIME KINEMATIC MODE. CORNERS AND MONUMENTS RECOVERED AND USED FOR THE SURVEY ARE NOTED. CERTAIN PUBLIC LAND SURVEY CORNERS AND 1/16TH CORNERS SET FOR ALLOTMENT BOUNDARIES WERE SEARCHED AND RECOVERED OR CALCULATED AS NOTED ON THIS RECORD OF SURVEY. CORNERS SEARCHED BUT NOT RECOVERED ARE SHOWN.

RECORDED SURVEY NUMBER 98-138-B WAS USED AS THE BASIS OF BEARINGS FOR THIS SURVEY.
