COUNTY: Umatilla DATE: 04/03/06

CORNER DESIGNATION: 3N31, Z-15, The South One-Quarter Corner of Section 34.

PREVIOUS RENEWALS/SURVEYS ETC.: Corner established by Josiah A. Burnett, under Contract No. 92, dated September 12, 1860. Record states: Set a post for 1/4 Sec. corner, drove charred stake and raised mound with trench, as per instructions.

MONUMENT SET:

Re-established corner by single proportionate measure on parallel of latitude holding the recovered Southwest corner of Section 34 and the reestablished Southeast corner of Section 34. At the reestablished corner position, set a 2 3/8" brass cap on 1 1/4" x 30" galvanized iron pipe with top 2" above ground level and surrounded with mound of earth. Monument marked as shown in monument marking detail.

From which:

A 5/8"x24" iron rebar with 1 1/4" red plastic cap stamped "OR PLS 1106 WA PLS 17372" at the base of a power pole guy anchor bears North 81° East, 37.9 feet.

A 3/4" brass washer stamped "PLS 1106" 1 foot above ground level in PP&L power pole No. 345000 bears South 67° East, 41.2 feet.

A 5/8"x24" iron rebar with 1 1/4" red plastic cap stamped "OR PLS 1106 WA PLS 17372" 6" North of the North right-of-way fence of Interstate 84 bears North 69° West, 19.9 feet.

A 5/8"x24" iron rebar with 1 1/4" red plastic cap stamped "OR PLS 1106 WA PLS 17372" 6" North of the North right-of-way fence of Interstate 84 bears North 66° West, 45.2 feet.

Attached bearing object signs to all accessories. Attached witness sign to right-of-way fence 1.5' South of monument.

LOCATION AND COMMENTS: Corner is located 1.5' North of the North right-of-way fence of Interstate 84, and 4 feet South of the South edge of a field road.
