

**OREGON CORNER RESTORATION FORM**

COUNTY: Umatilla DATE: 02/21/06

CORNER DESIGNATION: 2N31, C-5, The East One-Quarter Corner of Section 6.

PREVIOUS RENEWALS/SURVEYS ETC.: Corner established by Josiah A. Burnett, under Contract No. 92, dated September 12, 1860. Record states: Set a post for 1/4 Sec. corner, drove charred stake and raised mound with trench, as per instructions.

**MONUMENT AND ACCESSORIES FOUND:**

Found and held a old mound of stone that lines up with a farmed field line running East approximately 800 feet from corner as the best remaining evidence of the original corner. There are newer mounds of stone running North and South from the corner.

**MONUMENT SET:**

At the point in the center of the mound of stone set a 5/8" x 24" rebar with 2" aluminum cap 22" in the ground to bed rock and rebuilt the existing mound of stone. Monument marked as shown in monument marking detail.

From which:

A 5/8" x 24" rebar with 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372" bears North 12° East, 30.8 feet.

A 5/8" x 24" rebar with 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372" bears North 49° East, 19.8 feet.

A 5/8" x 24" rebar with 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372" bears South 59 1/2° West, 42.1 feet.

A 5/8" x 24" rebar with 1 1/4" yellow plastic cap marked "OR PLS 1106 WA PLS 17372" bears South, 26.9 feet.

Attached bearing object signs to all rebar accessories. Set steel fence post with witness sign 2 feet South of corner.

LOCATION AND COMMENTS: Corner located on rocky ridge top 50 feet West of an old field road along a farmed field.
