

**OREGON CORNER RESTORATION FORM**

Section 10 Township 4N Range 37E

County Umatilla Date 12/5/94

CORNER DESIGNATION: J-15

**Previous Renewals/Surveys, etc.**

Corner originally established by Charles L. and William C. Campbell under GLO Contract number 733, dated March 22, 1901. Surveyor General records state: Set a stone 15"x 10"x 8", 5" in the ground, struck rock, raised mound of stone around for 1/4 sec. cor. marked 1/4 on the North face; raised mound of stone, 2 ft. at the base, 1 1/2 ft. high North of corner. Pits are impracticable.

**Monument(s) & Accessories Found: (Condition and Source)**

No evidence was found. There is no basalt stone that fits the original dimensions. Area has sluffed off down the hill.

**Monument Set (Procedures and Description):**

At the midpoint between the recovered S.E. and the S.W. corners of Section 10 set a 2 1/2" brass cap on a 1 1/2"x 30" galvanized iron pipe, 21" in the ground, surrounded by a mound of earth and stone. Brass cap marked as shown above.

**New Accessories:**

A 5/8" x 30" rebar with a 1 1/2" aluminum cap bears N 19 1/2° W, 14.95 ft. Cap is marked "RM 14.95'FT.-S 10-1994."  
A 5/8" x 30" rebar with a 1 1/2" aluminum cap bears N 33° E, 13.65 ft. Cap is marked "RM 13.65'FT.-S 10-1994."  
A 5/8" x 30" rebar with a 1 1/2" aluminum cap bears S 21° E, 14.30 ft. Cap is marked "RM 14.3'FT.-S 15-1994."  
A 5/8" x 30" rebar with a 1 1/2" aluminum cap bears S 45° W, 11.15 ft. Cap is marked "RM 11.15'FT.-S 15-1994."  
All RM's have a steel fence post alongside with a witness corner sign and bearing object tag attached.  
Set a steel fence post 1 foot West of corner monument with a witness sign attached.

**Location & Comments:** The corner is located on a east facing slope approximately 1200+/- feet from the Walla Walla river road. Corner is 250 feet out of the bottom of Cougar Creek Canyon.
