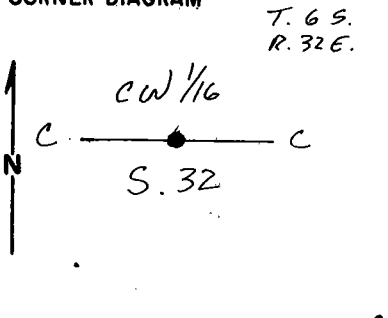

CORNER LOCATED AT BASE OF STEEP NORTH SLOPE IN THE N 1/2 OF
THE SW 1/4 OF SEC. 32. FOLLOW LOGGING ROAD IN N 1/2 OF NE 1/4 OF S. 32 APPROX.
3/10 MILE INTO SECTION TO WHERE ROAD BEARS SOUTH. 300 FT. WEST OF
CURVE IS POSTED SUBDIVISIONAL LINE BETWEEN CORNERS NW 1/16 AND CW 1/16.
FOLLOW POSTED LINE 900' SOUTH GRADUALLY ASCENDING TO CW 1/16 CORNER
AT BASE OF STEEP NORTH SLOPE.
