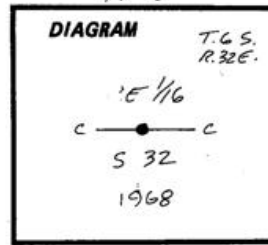


**CERTIFIED RECORD OF LAND CORNER MONUMENTATION**

History of original corner establishment: *BLM SET CORNER IN THE DEPENDENT RESURVEY, PORTION OF SUBDIVISIONAL LINES, SUBDIVISION OF SECTION 32, T. 6 S., R. 32 E., WILLAMETTE MERIDIAN, OREGON 1968. SET IRON POST, 28" LONG, 2 1/2" DIAM., 24 INCHES IN THE GROUND, IN A MOUND OF STONE, 2 1/2 FT BASE TO TOP, WITH BRASS CAP MKD.*
