Robnett Street Vacation Report

General

A petition was received in December, 2007 from John and Janet Lamb to vacate the west 30 feet of Robnett Street, a platted public road in the Sand Bur Rancho Addition to Umatilla County located in and adjacent to the northeastern portion of the City of Umatilla. The petition was signed by 100% of the abutting property owners. The reason for vacating the west 30 feet of the road is to allow construction of a new garage in a portion of the road right-of-way. The right-of-way is not currently being or has ever been used as a traveled road.

History

The subdivision was created (recorded) in 1947. Several portions of the platted roads within this subdivision have been vacated over the years. A map summarizing those vacations is attached. As stated above, the portion of Robnett Street the Lambs are trying to get vacated has never been constructed or used as a traveled road.

Access Issues

No property would be landlocked by vacating this portion of the road.

Emergency Vehicles

Vacating this portion of the road would not effect access for emergency vehicles.

Utilities

The City of Umatilla has sewer and water lines installed in this portion of the right-ofway. Larry Clucas, City Manager, has no problem with vacating the road as long as a blanket easement for maintenance and repair of the utilities is maintained on the vacated road. No other utilities exist in this portion of Robnett Street.

Public Benefits

Vacation of this strip of road, which is 30 feet long and 60 feet wide would return approximately 0.04 acre to the tax rolls.

Public Hearing


A public hearing is not required (ORS 368.351), as 100% of the abutting owners have signed the petition.

Annexation

John and Janet Lamb are in the process of acquiring the west 30 feet of Tax Lot 3800 from Keith Rodenbough and Doris Hiatt. It is recommended that it along with the vacated road and the east 30 feet of Tax Lot 3903 to the south (which is in the County) be annexed in to the City.

Recommendation

The Public Works Department considers the road to be useless, and recommends that it be vacated as requested in the petition. Because the petition that was circulated included specific language requesting that John and Janet Lamb get ownership of the entire vacated road, it is also recommended that ownership of the entire vacated road vest in the Lambs, as allowed by ORS 368.366(2).



We, Petitioners, (SEE "PETITIONERS" NEXT PAGE) petition the Board of County Commissioners of Umatilla County, Oregon to vacate the westerly 30 feet of Robnett Street, a platted public road in the Sand Bur Rancho Addition, located in the Northwest ¼ of the Northwest ¼ of Section 16, Township 5 North, Range 28 E.W.M. (See Attached Drawing).

II

Petitioners are the owners, as shown in the records of Umatilla County, of property abutting the road sought to be vacated, (and petitioners are the only persons or corporations particularly affected by the proposed vacation of the road).

Ш

No portion of the road proposed to be vacated is situated within the corporate limits of any city.

IV

The particular circumstances that justify granting a vacation of the described road are:

HOW PROPERTY IS USED: The portion of the right-of-way in question has never been used for road purposes. It has been fenced in and used as a portion of Tax Lot 3905 for several years.

CONDITION OF PROPERTY: Currently, excavation for footings for a new garage has been started. Utilities exist in the road proposed to be vacated and a blanket utility easement for the City of Umatilla and others would need to be reserved should it be vacated.

REASON FOR VACATION: John and Janet Lamb, owners of Tax Lot 3905, received a building permit to construct a new garage, not knowing that the location of the new garage was in an un-vacated public road right of way. Construction was started, but upon realizing the building was in the platted road right of way, the City of Umatilla revoked the building permit. It is requested that ownership of the entire vacated road go to John and Janet Lamb, as allowed by ORS 368.366(2).
