HERMISTON PUBLIC SAFETY CENTER SUPPORT NEEDED \$8 MILLION REQUEST

The Hermiston Public Safety Center, a vital community asset since 1972, urgently requires a \$8 million funding infusion for essential renovations. With over 50 years of service, the facility houses the Hermiston Police, Umatilla County Fire District # 1, emergency operations center and the regional Team 10 Hazardous Materials response vehicle.

MISSION CRITICAL NEEDS:

- **1. Seismic Rehabilitation:** The aging structure demands immediate seismic strengthening for public safety for which the city has received a grant for that work.
- 2. Living Quarters Remodeling: Equitable living quarters for firefighters ensure a modern and inclusive environment.
- **3. Office Spaces and ADA Compliance:** Modernization of office spaces to meet ADA standards, support growth, and enhance customer service.
- **4. Emergency Alerting System:** Installation of an emergency alerting system for improved communication and response on the fire station side.
- **5. HVAC System Upgrade:** Enhancing air quality and energy efficiency through a comprehensive HVAC system upgrade.
- **6. Sally Port and Training Room:** Essential construction for police operations, secure processing, and ongoing training.
- **7. Parking Area Enlargement:** Enlarging parking areas for police, fire personnel, and public use.

WHY URGENT LEGISLATIVE SUPPORT MATTERS:

- **Public Safety Impact:** The Hermiston Police Department and Umatilla County Fire District # 1 are critical to the safety of Hermiston and surrounding communities, responding to a substantial number of calls annually.
- **Community Resilience:** The Public Safety Center is a cornerstone for emergency response, housing the emergency operations center and regional hazmat team truck.
