2022-2023 Supplemental Budgets and Budget Transfers

Scheduled for June 21, 2023

Fourteen Budget Transfers are scheduled for consideration on June 21, 2023. The orders under consideration are attached and referenced by order number for your convenience.

Budget Order 2023-136 Victim Witness Assistance

The <u>Victims Conference Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Materials & Services of \$10,000, and a decrease in Contingency of \$10,000.

Budget Order 2023-137 General Fund
