2023-2024 Supplemental Budgets and Budget Transfers

10 Transfers are scheduled for consideration on November 8, 2023. The orders under consideration are attached and referenced by order number for your convenience.

Budget Order 2024-03 General Fund

The <u>General County Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Transfers Out of \$319,645, and a decrease in Contingency of 319,645.

Budget Order 2024-04 General Fund

The <u>SO Jail Division Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Personnel Services of \$428,117, and a decrease in Contingency of \$428,117.

Budget Order 2024-05 General Fund

The <u>SO Administration Division Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Personnel Services of \$61,109, and a decrease in Contingency of \$61,109.

Budget Order 2024-06 General Fund

The <u>SO Criminal Division Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Personnel Services of \$422,819, and a decrease in Contingency of \$422,819.

Budget Order 2024-08 General Fund

The <u>General County Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Transfers Out of \$637, and a decrease in Contingency of \$637.

Budget Order 2024-09 General Fund

The <u>Board of Commissioners Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Materials & Services of \$200,000, and a decrease in Contingency of \$200,000.

Budget Order 2024-16 Community Benefit Plan

The <u>Local Improvement Distribution Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Transfers Out of \$420,000, and a decrease in Contingency of \$420,000.

Budget Order 2024-20 General Fund

The <u>General County Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Transfers Out of \$35,000, and a decrease in Contingency of \$35,000.

Budget Order 2024-21 County Fair

The <u>County Fair Program</u> requires an Appropriations Transfer to appropriate funding not known at the adoption of the budget. This requires an increase in Capital Outlay of \$20,000, and a decrease in Contingency of \$20,000.

Budget Order 2024-22 BMIP Reserve
