SUBJECT: Contractor to come in to move the Dispatch Consoles when the New flooring is installed

Background: The dispatch flooring was approved to be replaced back in the summer of 2023.

Due to scheduling and supply lines, this has been delayed and is anticipated to be done in mid-January by the approved supplier.

As the dispatch consoles are expensive, highly mechanically driven and are an essential tool for dispatch, the movement of the desks for the installation of the flooring, needs to be done by a professional.
