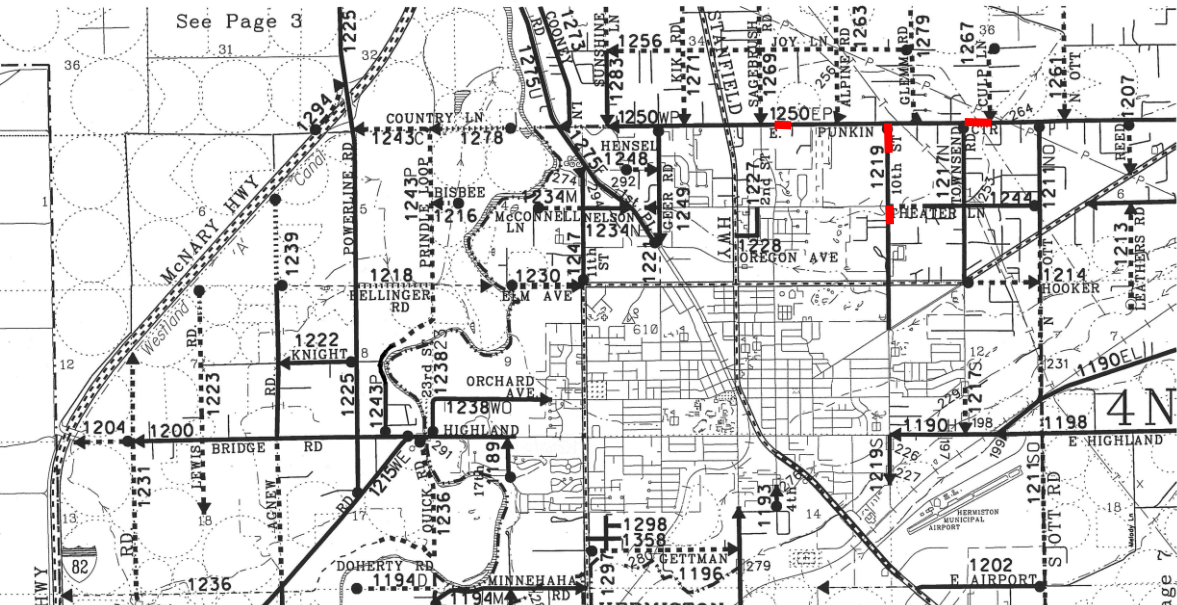

Parking Signs on Punkin Center Road ) ORDER NO. RD2025-04  
(County Road No 1250) and NE 10<sup>th</sup> Street )  
(County Road No. 1219) )

WHEREAS, the Board of County Commissioners has authority to place and maintain traffic control devices on County Roads, pursuant to ORS 810.210(2);

WHEREAS, oversized loads have been parking on Punkin Center Road and NE 10<sup>th</sup> Street;

WHEREAS, it furthers appears to the Board of Commissioners that Parking on Punkin Center Road and NE 10<sup>th</sup> Street hinders traffic to travel safely through the area;

WHEREAS, the Public Works Director has investigated this issue and recommends that "No Parking" signs be installed on portions of Punkin Center Road (County Road No 1250) and NE 10<sup>th</sup> Street (County Road No. 1219).

NOW, THEREFORE, IT IS HEREBY ORDERED that "No Parking" signs be installed on the following portions of County Roads:

1. Punkin Center Road (County Road No 1250) - North side - From 650 feet East of Sagebrush Road (Umatilla County Road No. 1269) East for approximately 600 feet;
2. Punkin Center Road (County Road No 1250) - North and South sides - From Townsend Road (County Road No. 1217) to Culp Lane (County Road No. 1267) for approximately 800 feet;
3. NE 10<sup>th</sup> Street (County Road No 1250) - East and West sides - From Punkin Center Road (Umatilla County Road No. 1250) South for approximately 900 feet;
4. NE 10<sup>th</sup> Street (County Road No 1250) - East and West sides - From Theater Lane (Umatilla County Road No. 1250) South for approximately 600 feet;
