Budget Order 2026-34 **Developmental Disabilities**

The **Developmental Disabilities Program** requires a Supplemental Budget to appropriate funding not known at the adoption of the budget. This requires an increase in Federal Revenue of \$300,000, and an increase in Materials & Services of \$300,000.
