2024-2025 Supplemental Budgets and Budget Transfers

Scheduled for May 21, 2025

Four Supplemental Budgets are scheduled for consideration on May 21, 2025. The orders under consideration are attached and referenced by order number for your convenience.

Budget Order 2025- 62 **EOTEC Reserve**

The <u>EOTEC – Reserve Program</u> requires a Supplemental Budget to appropriate funding not known at the adoption of the budget. This requires an increase in Local Revenue of \$3,000, and an increase in Materials & Services of \$3,000.

Budget Order 2025-63 **Justice Reinvestment**

The <u>Justice Reinvestment Program</u> requires a Supplemental Budget to appropriate funding not known at the adoption of the budget. This requires an increase in State Revenue of \$100,000, and an increase in Materials & Services of \$100,000.

Budget Order 2025-64 Wellness Hubs
