#### Tuesday, June 6, 2023

**Committee members present:** Brad Bixler, Kylie McClintock, Jerry Terjeson, and Dan Dorran.

#### Committee chair, Jerry Terjeson called the meeting to order at 2:15 pm.

Dan Dorran moved to approve the minutes from the May 1st, 2022 HELP Committee meeting. Brad Bixler seconded the motion. The motion passed with a 4-0 vote.

#### Old Business:

The committee reviewed the 2022 HELP projects.

Brad Bixler presented the Helix School District 2022 fund request for \$3,486.00 (see attached application). A mural was painted in the Helix School Weight Room. The project has been completed.

Brad Bixler shared the paperwork that the Helix School District has been reimbursed **\$3,486.00** 

Kylie McClintock stated that the City of Helix is still trying to spend their 2022 HELP money. They have been trying to get a speed sign but have run into some issues in doing so. They may re-evaluate what it is that they want and may change the scope. **The City will not be requesting reimbursement at this time.**

Brad Bixler presented the Helix School District 2023 fund request for \$ **14,250** (see attached application). The Helix School is requesting financial support to add access control to 12 exterior doors and one interior door. This project will greatly increase the ability of the school to maintain a safe and controlled environment. Limiting access or delaying the access of any individual or group that is interested in doing harm to students or staff is a critical component to the Helix School District's overall safety plan.

Brad Bixler made a request for reimbursement of **\$14,250**.

Kylie McClintock presented the City of Helix 2023 fund request for \$14,250 (see attached application). The City would like to install a new mini split heating and cooling system in the City Hall. In addition, they would like to enhance the area around the newly acquired "Ticket House" by adding a small retaining wall on the back side of the property and a memorial garden that will be maintained by the City Library.

Jerry Terjeson asked why the money was higher than in the past. Dan will find out a spreadsheet of what is left and the possible money available next year.

Next meeting was discussed and will likely occur the last week in May or the first week in June of 2024, but scheduling will dictate the exact date.

This access control system will utilize electronic locks and exterior key pads and card swipes to restrict access to the school building by keeping all but one exterior doors locked during school hours. The vestibule area will allow office staff to view and talk with individuals prior to them receiving entrance to the school building.
