§72.01 ATV USE ON DESIGNATED COUNTY ROADS.

(A) Subject to the provisions of this Chapter 72 and Oregon law, Class I, II and IV all-terrain wheeled vehicles may be operated on designated County Roads. This Chapter does not apply to or restrict vehicles under ORS 821.191 used for agricultural purposes. Nothing contained in this Chapter applies to the operation of snowmobiles as that term is defined by ORS 801.490.

(B) The County Roads designated for use by All-Terrain Vehicles will be those two lane gravel County Roads, paved County Roads with a posted speed limit of 40 miles per hour or less, and other County Roads, as designated by the County, located easterly of State Highway 11, easterly of State Highway S. 395 (Pendleton to Nye Junction), and southerly of State Highway 74. Public Roads within this area and not accepted as and designated as County Roads and any road under the jurisdiction of another governmental entity or agency are excluded from and not covered by this Chapter, and excluding any road on the Confederated Tribes of the Umatilla Indian Reservation. The roads

designated for use are shown in the attached map marked Exhibit A, and listed on Exhibit B. (Ord. 2025-08, passed 12-17-2025)

§72.02 OPERATOR REQUIREMENT.

(A) The operator of the allowed all-terrain vehicle must be 16 years of age or older, and hold a valid state issued Driver's License. Licensed drivers must comply with all license restrictions. A person may not operate an ATV under this Chapter while the person's driving privileges (i.e. Driver's License) are suspended or revoked.

(B) For any operator under the age of 18 another adult person must also be along as required by ORS 821.170, ORS 821.172, and ORS 821.176.

(C) A person operating a Class I All-Terrain Vehicle must hold a valid Class I ATV Safety Education Card Operator Permit issued under ORS 390.570. A person operating a Class IV All-Terrain Vehicle must hold a valid Class IV ATV Safety Education Card issued under ORS 390.577. The operator must have any other permit required by the State of Oregon for operating an ATV. (Ord. 2025-08, passed 12-17-2025)

§72.03 VEHICLE REQUIREMENTS.

(A) All-Terrain Vehicles operated under this Chapter must be wheeled only and equipped with the safety equipment required under all applicable Traffic Laws, including, without limitation, ORS 821.030, ORS 821.040, ORS 821.220, ORS 821.230, and

OAR 735-116-0000. No tracked vehicles are permitted.

(B) The all-terrain vehicle must be equipped with rearview mirrors, brakes, display headlights and taillights, minimum of 150 cc engine capability, and pennant to attract attention.

(C) Mufflers in Oregon must be maintained at 99 decibels (db) and be in compliance of ORS 467.030 and OAR 340-035-0030.

(D) The vehicle must have a valid Oregon state issued ATV operating permit (sticker) or any other permit required by the State of Oregon.

(E) All-Terrain Vehicles operated under this Chapter must meet the financial responsibility requirements under ORS 806.060. For purposes of this Chapter, "financial responsibility requirements" means the ability to respond in damages for liability, on account of accidents arising out of the ownership, operation, maintenance, and/or use of an ATV, in a manner provided under ORS 806.060.

(F) The all-terrain vehicle must be equipped at all times with an approved spark arrestor as specified in OAR 629-043-0015(1)(b).

without limitation, all applicable Traffic Law requirements (including, without limitations, ORS 811.255) and operated in compliance with all posted speed limits and may not be operated (a) at a rate of speed greater than reasonable under the existing conditions, or (b) in a negligent manner so as to endanger or cause injury, death, and/or damage to the operator or person or property of another. It is the responsibility of the operator to be aware of which County Roads are open to use by all-terrain vehicles.

(B) Any operator or passenger must wear a Motorcycle Helmet with a fastened chin strap at all times if operating or riding on a Class I, or if under the age of 18 for any Class of vehicle.

(C) No passenger may be under the age of 5.

(D) A person must be properly secured with a safety belt or safety harness while operating or riding as a passenger on an ATV operated under this Chapter if such ATV was required to be equipped with safety belts or safety harnesses at the time the ATV was manufactured or safety belts or safety harnesses have been installed on the ATV (ORS 811.210).

(E) In the event of a ban on burning adopted by the Board of Commissioners, use of the County Roads may be restricted for All-Terrain Vehicle Use.

(F) All-Terrain Vehicles operated under this Chapter may be operated only during daylight hours. For purposes of this section, daylight hours mean one-half hour after sunrise to one-half hour before sunset. Headlight and taillights must be used at all

§72.04 VEHICLE OPERATION.

(A) All-Terrain Vehicles operating under this Chapter must be operated in compliance with all applicable federal, state, and local laws, regulations, and ordinances, including,

§72.05 LIABILITY.

The operation of an ATV will be undertaken at the sole risk and responsibility of the owner and/or operator. Umatilla County, in adopting this Chapter, assumes no responsibility for the operation of such ATVs and will be held harmless in any action arising from the operation of such ATVs on or off any public way within Umatilla County, including, without limitation, roadways.

§ 72.06 ENFORCEMENT AND PENALTIES.

(A) Enforcement of this Chapter may be through Umatilla County Code of Ordinances Chapter 38, or by civil action as provided in ORS 30.310, 30.315 or ORS Chapter 203, or by any means allowed under Oregon law.

(B) Any violation of this Chapter that constitutes a violation of a Traffic Law, then the penalty for the same shall be as provided for by Oregon statute.

(D) The failure or omission to comply with any section of this Chapter shall be deemed a violation and may be so prosecuted, subject to the fines provided in this Chapter and Chapter 38.

§72.06 DEFINITIONS.

For the purpose of this Chapter, the

following definitions are established:

(a) All-Terrain Vehicle(s) (“ATV”), includes those Classes defined under ORS Chapter 801. Snowmobiles, as defined in ORS 801.490, are excluded from this Chapter and are not included within any authorization to use of County Roads.

(1) Class I ATVs: as defined in ORS 801.190 as a motorized, off-highway recreational vehicle 50 inches or less in width with a dry weight of 1200 pounds or less that travels on three or more low pressure tires, has a saddle or seat for the operator and is designed for or capable of cross-country travel on or immediately over land, water, sand, snow, ice, marsh, swampland or other natural terrain. Most riders refer to a Class I All-Terrain Vehicle as an ATV or quad.

(2) Class II ATVs: as defined by ORS 801.193 as any motor vehicle that weighs more than or is wider than a Class I All-Terrain Vehicle, is designed for or capable of cross-country travel on or immediately over land, water, sand, snow, ice, marsh, swampland, or other natural terrain, and is not a Class IV All-Terrain Vehicle. Class II All-Terrain Vehicles may also be known as four-by-fours, pickups, jeeps, sand rails, dune buggies, and SUVs.

(3) Class III ATVs: as defined in ORS 801.194(1) as a motorcycle that travels on two tires. Most riders refer to a Class III All-Terrain Vehicle as a dirt bike.

(4) Class IV ATVs: as defined in ORS 801.194(2) as 75 inches wide or less at its widest point, has a dry weight of 3,500 pounds or less, has non-straddle seating,

has a steering wheel for steering control, travels on four or more tires, and was originally manufactured for off-road use only. These are commonly known as a side-by-side or UTV.

(b) ATV Safety Education Card, means the ATV Safety Education Card issued upon completion of an Oregon Parks and Recreation Department approved ATV Safety Education course and passage of the minimum standards test of ATV Safety Education competency as established by the Oregon Parks and Recreation Department as set forth in OAR 736-004-0015(10).

(c) ATV operating permit means the ATV operating permit issued under ORS 390.580 and is a decal that authorizes use of the ATV and must be permanently affixed to the vehicle and displayed in a clearly visible manner.

(d) Driver License, has the meaning given that term under ORS 801.245.

(e) Motorcycle Helmet, has the meaning given that term under ORS 801.366. ORS 801.366 defines a Motorcycle Helmet as a protective covering for the head consisting of a hard outer shell, padding adjacent to and inside the outer shell and a chin-strap type retention system with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation. The padding must be internal impact padding.

(f) Traffic Law(s), means any and all Oregon statutes and regulations relating in any way to the operation or use of motorized vehicles, including, without limitation, the Oregon Vehicle Code (ORS Chapters 801 to

826) and any regulations or administrative rules promulgated thereunder.

§72.07 SIGNS.

The County will post signs giving notice that the operation of ATVs is permitted upon certain County Roads under the provisions of this Chapter that are not graveled County Roads or paved County Roads with a posted speed limit of 40 miles per hour. The County will post such signs at locations necessary to inform the public that ATVs are permitted, which sign locations will be determined by the County in its sole discretion.
