

IN THE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY

In the matter of the Report :
of County Road Viewers : ROAD No. 868

Now on this day this matter coming on to be heard upon the report of the Board of County Road Viewers, heretofore instructed to view and report upon said proposed road, and said report having been publicly read on two different days of the same term of court, to-wit: having been publicly read the first time on August 3rd, 1927 and publicly read the second time on August 4th, 1927, and is now up for final hearing, and the Court finds that no objection or exceptions are on file against said road or report, and said Board of viewers, finds that said road as laid out would be a practicable and necessary one and a benefit to the general public, and recommended that said road be opened and established as a county road of Umatilla County, Oregon.

Said Board further finds that the owners of the land through which said road is to be laid out and established will be rendered less valuable, by reason of its establishment, as follows:

IT IS THEREFORE HEREBY ORDERED that said report of the Board of County Road Viewers be approved, that said road be established and declared a public highway of Umatilla County, Oregon, and that the width of said roadway or right of way be a strip of land sixty feet wide, being 30 feet wide on each ^{side} of its centerline as described in the original resolution herein.

It is further ordered that the Clerk of this Court be instructed to draw warrants to pay the necessary expenses of viewing said road and

to draw warrant to pay such damages as are herewith awarded by the Board of viewers.
