RESOLUTION

County Road No. 868.....

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed in the territory lying between Wild Horse Creek and Spring Hollow in Township 3 North, Range 35 East, W.M.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of November 1926, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road No. 868

shall commence, run and terminate as follows, to-wit:

Beginning at Station 200 + 00 of the Eagle Creek Market Road survey, which point is 1430 feet North and 330 feet East of the Quarter Section corner common to Sections 4 and 9, Township 3 North, Range 35 East, W.M., said point being also in the center of County Road No. 857, thence running southerly following the Eagle Creek Market Road survey to Station 428 + 49, which point is 160.8 feet South and 152.9 feet East of the Northwest corner of the Northeast Quarter of the Northeast Quarter of Section 28, Township 3 North, Range 35 East, W.M. Said point of ending is also in the center of County Road No. 865.

The right of way or roadway to be a strip of land Sixty (60) feet wide, being Thirty (30) feet wide on each side of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: That it provides a direct connection for the Athena, Weston and East End sections of Umatilla County with the Umatilla River country.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by the County Roadmaster as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
