RESCLUTION ROAD No. 856

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Highway or road be located, established, altered, widened, straightened and changed on territory leading from what is known as the foot of Emigrant Hill to Deadman's Pass in the County of Umatilla, State of Oregon, said Highway or road being commonly known and designated as the Old Oregon Trail and that said Highway or road be located, established, altered, straightened, widened and changed by Resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS This being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of the County of Umatilla, State of Oregon, sitting at the regular monthly term for the month of July in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is, and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a highway or road on and over a route as follows:

BE IT RESOLVED that the proposed County Road or Highway No. 156 shall commence, run and terminate as follows, to-wit:

corner common to Sections 13, 14, 23 and 24, Township 2 North, Range

The width of the said right-of-way or road way to be a strip of land forty feet wide on each side of the above described line, making a total highway or road way eighty (80) feet in width.

BE IT FURTHER RESOLVED: That a public necessity for said highway or road is hereby declared to exist for the following reason, to-wit: That the existing highway between what is known as the Foot of Emigrant Hill and Deadman's Pass is inadequate on account of short curves and lack of width to accommodate the present traffic.

BE IT FURTHER RESOLVED: That the above entitled matter be heard at the regular July term for the year 1925 of said County Court at the County Court Room in the Court House at Pendleton, in the County of Umatilla, State of Oregon.

BE IT FURTHER RESOLVED: That true copies of this Resolution, properly certified to as such by the County Clerk, be posted by the County Road Master as follows, to-wit: That a copy be posted upon the Bulletin Board at the North entrance of the Court House in the City of Pendleton, Umatilla County, State of Oregon, said Court House being the place where the County Court is held; that one copy be posted at the initial or beginning point of said proposed road; that one copy be posted at the end of the said proposed road; and that one copy be posted in the vicinity of the said proposed road at some point between the beginning and the end of the said proposed road, and that this Resolution be duly entered in the Commissioner's Journal.
