in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in

the State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet wide on each side of the center line of said road as surveyed over and across portions of Sections

3, 9 and 16, Township 2 North, Range 31 East, W.M. and more particularly described as follows; Beginning at a point known as Station 28 / 47, which point is 320 feet East

of the Quarter Section corner common to Sections 3 and 4, thence running Southwesterly following the said road survey, 730 feet to a point known as Station 35 / 77, which

point is 667 feet South of the Quarter Section corner common to Sections 3 and 4. Also beginning at a point known as Station 60 / 34, which point is 446 feet West of the

Section corner common to Sections 3, 4, 9 and 10, thence running Southwesterly follow the said road survey, 7720 feet to a point known as Station 137 / 52, which point is

in the center of the Old Oregon Trail and 460 feet North and 930 feet West of the 1/4 Section corner common to Sections 15 and 16, all in Township 2 North, Range 31 East,
