OF-WAY AS A COUNTY ROAD )

WHEREAS, Umatilla County has acquired Tax Lot 590 in the Elwood Subdivision, more particularly described below from Glenn and Pearl Elwood by tax foreclosure deed dated June 24, 1969 and filed in Book 300, Page 302 of the Umatilla County Deed Records pursuant to ORS 312.200; and

WHEREAS, the Board of Commissioners finds that the property is adjacent to a county road known as Second Street in Elwood Tract; and

WHEREAS, the Board of Commissioners further finds that dedication of the property to public use would be beneficial to the health and welfare of the people of Umatilla County, Oregon, by providing access from Second Street to East Theater Lane;

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Umatilla County hereby grants the following described property known as Tax Lot 590 to be dedicated forever to the public for road purposes and further is accepted by Umatilla County as a county road;

Beginning at the Northwest corner of the Southwest Quarter of Section Two, Township Four North, Range twenty-eight, E.W.M., thence East 53 feet; thence South 20 feet to the Northwest corner of Elwood Tracts, Umatilla County, Oregon; thence East along the North line of said Elwood Tracts, a distance of 716 feet to the point of beginning of this description; thence South 204 feet to the Northwest corner of Lot One in Block Three in said Elwood Tracts; thence West along the North line of Said Elwood Tracts a distance of 60 feet; thence North 204 feet; thence East 60 feet to the point of beginning.

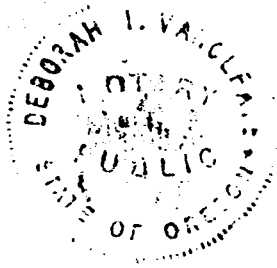
