KNOW ALL MEN BY THESE PRESENTS, that Lewellyn Brownell and Jane Brownell, husband and wife, of the County of Umatilla and State of Oregon, in consideration of the benefits and other valuable considerations and the sum of \$1.00 paid them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land situate in Umatilla County, State of Oregon, to-wit:

PARCEL #1. A parcel of land lying in the Southwest quarter (SW $\frac{1}{4}$) of Section 9, and in the Northwest quarter (NW $\frac{1}{4}$) of Section 16, Township 5 North, Range 28 East, W. M., Umatilla County, Oregon, the said parcel being all that portion of the owner's property included in a strip of land 30 feet in width, on the Westerly side of the center line of the Umatilla Oil Depot Access Road, as said road has been relocated over and across or adjacent to the said property; the location of the said strip of land (insofar as it encroaches upon said property) being determined by the said center line from Station 12+16 to Station 25+98 which portion of center line is described as follows:

Beginning at a point which is Engineer's center line Station 12+16 opposite and 30 feet distant from which point the Westerly line of the said strip of land intersects the Northerly right of way line of the O.W.R. & N. Co.; said point being 385 feet South and 1320 feet East of the Northwest corner of Section 16, Township 5 North, Range 28 East, W.M.; thence North 0° 11' East a distance of 1382 feet to Engineer's Station 25+98 at which station the said center line intersects the North line of the owner's property.

The parcel of land to which this description applies contains 0.95 acre, of which 0.63 acre lies within the existing road right of way, title to which hereby is acknowledged to be in the public, and 0.32 acre lies outside of the existing right of way.

PARCEL #2. A parcel of land lying in the Southwest quarter (SW $\frac{1}{4}$) of Section 9, Township 5 North, Range 28 East, W. M., Umatilla County, Oregon, the said parcel being all that portion of the owner's property included in a strip of land 30 feet in width on the Easterly side of the center line of the Umatilla Oil Depot Access Road as said road has been relocated over and across or adjacent to the said property; the location of the said strip of land (insofar as it

encroaches upon said property) being determined by the said center line from Station 19+38 to Station 26+06 which portion of center line is described as follows:

Beginning at a point which is Engineer's center line Station 19+38 at which station said center line intersects the Southerly line of the owner's property; said point being 337 feet North and 1320 feet East of the Southwest corner of Section 9, Township 5 North, Range 28 East, W. M. thence North 0° 11' East a distance of 668 feet to Engineer's Station 26+06, opposite and 30 feet distant from which station the Easterly line of said strip of land intersects the Northerly line of the owner's property.

The parcel of land to which this description applies contains 0.46 acre, of which 0.30 acre lies within the existing road right of way, title to which hereby is acknowledged to be in the public, and 0.16 acre lies outside of the existing right of way.

TO HAVE AND TO HOLD the same unto the County of Umatilla, State of Oregon for the purpose of a public road forever.
