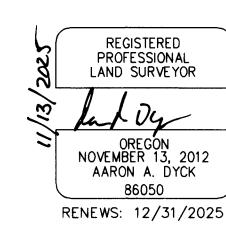
#### SURVEYOR'S NARRATIVE

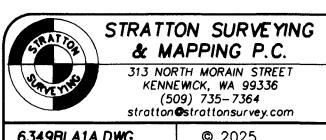
THIS SURVEY WAS PERFORMED AT THE REQUEST OF ROGERS TOYOTA FOR THE ADJUSTMENT OF THE BOUNDARIES BETWEEN TAX LOTS 1505, 1703, AND 1500, ALL MAP 5N 28 34D; TAX LOT 1500 WILL BE COMPLETELY CONSOLIDATED INTO TAX LOTS 1505 AND 1703.

DENNIS EDWARDS HAS PERFORMED THE MAJORITY OF THE SURVEYS IN THIS AREA AND HIS EARLY SURVEYS PREDATED CS S-156-C PERFORMED BY DAVID KRUMBEIN WHICH REMONUMENTED THE SOUTH QUARTER CORNER AND THE SOUTHEAST SECTION CORNER. HIS NARRATIVE ON CS 11-118-B SAYS THAT HE CHOSE TO HOLD HIS 1976 LOCATIONS FOR THESE TWO SECTION SUBDIVISION CORNERS BECAUSE THE NEW LOCATIONS WERE APPROXIMATELY 3 FEET SOUTH OF HIS 1976 LOCATIONS AND OCCUPATION LINES WERE NOW ESTABLISHED TO HIS ORIGINAL 1976 CORNERS.

IN 2019 KEITH PRIMM SURVEYED PARTITION PLAT 2019-06 AND DID NOT ACCEPT THE CORNER HE FOUND AT THE SOUTHEAST CORNER OF HIS SUBJECT PROPERTY THAT WAS SET BY DENNIS EDWARDS ON CS N-091-A BECAUSE IT DID NOT FIT THE SUBDIVISION OF THE SOUTHEAST QUARTER. KEITH PRIMM USED THE MONUMENTS SET ON CS S-156-C AND THE SECTION SUBDIVISION SHOWN ON CS 94-61-B PERFORMED BY WILLIAMS WELLS TO SUBDIVIDE THE SECTION.

I CHOSE TO HOLD FOUND EDWARDS PINS FOR LINE AND INTERIOR DIMENSIONS OF PARCELS DEPICTED ON CS 09-002-A FOR THE BOUNDARIES OF TAX LOTS 1505 AND 1500 BECAUSE THIS MATCHED OCCUPATION LINES AND SOME REBARS ARE CALLED OUT IN THE DEED RECORDED UNDER INSTRUMENT NUMBER 2016-6460513. I HELD THE SECTION SUBDIVISION PER FOUND MONUMENTS SHOWN HEREON FOR THE WESTERLY BOUNDARY OF TAX LOT 1505 AND THE EASTERLY BOUNDARY OF TAX LOT 1500. I HELD THE EASTERLY BOUNDARY OF PARTITION PLAT 2019-06 AND PROJECTED NORTH TO THE SOUTHERLY LINE OF TAX LOT 1505 PER SC 009-002-A FOR THE WESTERLY LINE OF TAX LOT 1500. THIS DOES CAUSE A GAP BETWEEN THE NORTH LINE OF PARTITION PLAT 2019-06 AND TAX LOT 1505. I ESTABLISHED THE BOUNDARY OF TAX LOT 1703 WITH THE DEED RECORDED UNDER INSTRUMENT NUMBER 2024-07795 AND CS 94-061-B.
