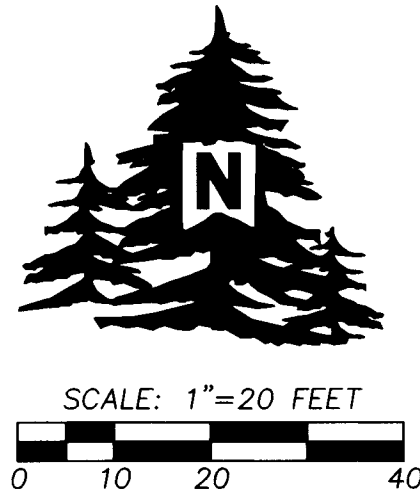


RECORD OF SURVEY



"BASIS OF BEARINGS" IS THE C/L OF S.W. OLSON AVE. AS SHOWN PER THE PLAT OF YOUNG'S 2ND ADDITION, AND SURVEY NO. F-015-AX.

- ◆ SET 5/8"x30" REBAR WITH 1 1/4" BLUE PLASTIC CAP MARKED "WELLS SURVEYING PLS 54657."
- FOUND 2" BRASS CAP IN MONUMENT BOX PER SURVEY NO. F-015-AX.
- FOUND DRILL HOLE AND HELD AS A WITNESS CORNER. SET 3/4" BRASS WASHER STAMPED "PLS 54657" IN LEAD IN THE DRILL HOLE. THIS IS A WITNESS CORNER. SEE WITNESS CORNER DETAIL.
- ⊙ FOUND 5/8" REBAR PER SURVEY NO. F-015-AX.
- ⊙ FOUND 1/2" REBAR. ORIGINAL PLAT MONUMENT, YOUNG'S 2ND ADD., BOOK 9, PAGE 1.
- ⊕ CALCULATED POINT ONLY. NOTHING FOUND OR SET.
- (XOX) RECORD DIMENSION PER THE PLAT OF YOUNG'S 2ND ADD., OR SURVEY NO. F-015-AX, BOTH SHARE IDENTICAL COMMON DIMENSIONS.

NOTE:

CURVE NO. 2 AND CURVE NO. 3 ARE NOT AN OFFSET OF C/L CURVE NO. 1. THEY ARE PORTIONS OF A THREE POINT CURVE CALCULATED HOLDING THE FOUND ORIGINAL 5/8" REBAR AND THE CALCULATIONS ON EACH SIDE THEREOF. THIS IS WHY THE RADIUS DOES NOT MATCH THE RECORD.

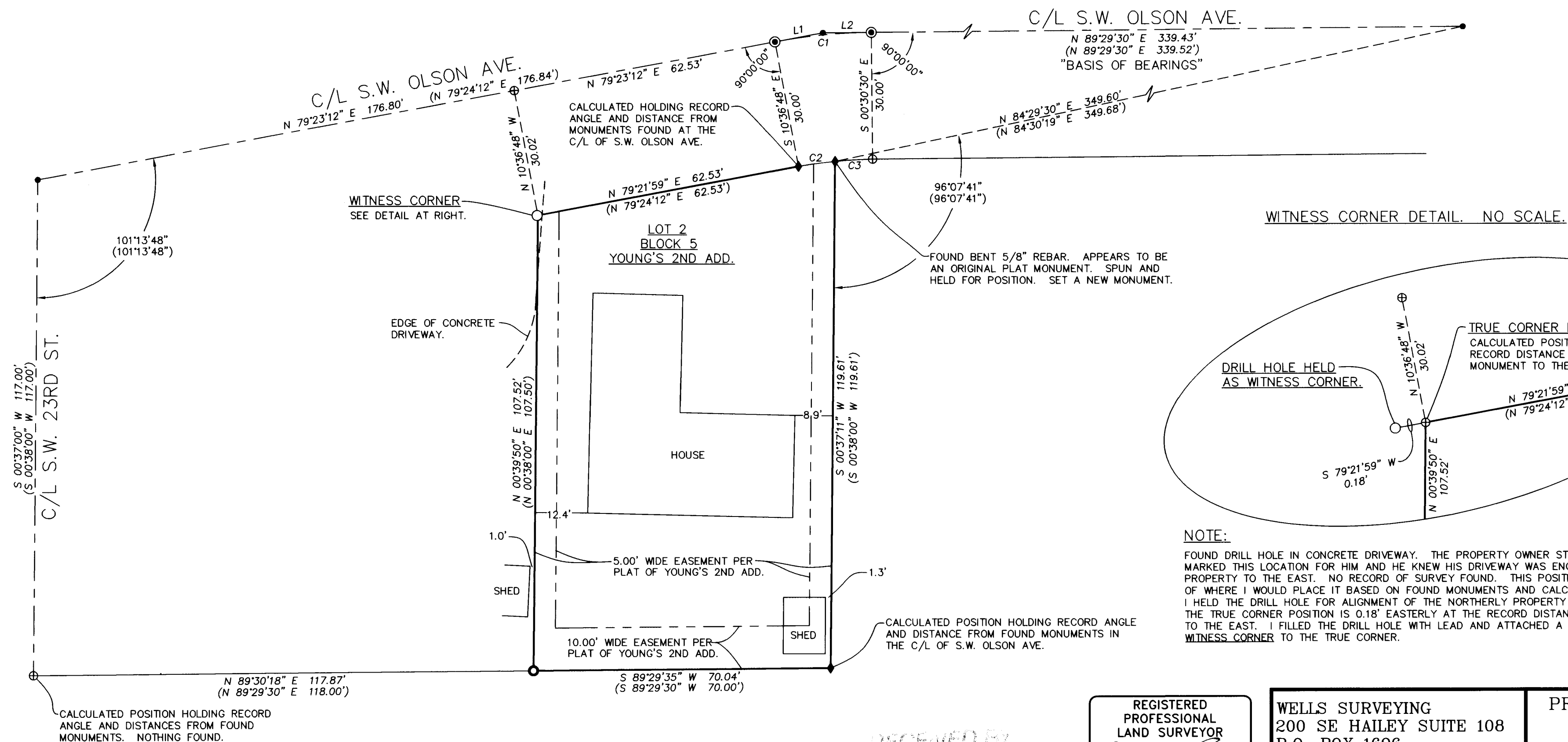

NARRATIVE

THIS SURVEY WAS MADE AT THE REQUEST OF THE PROPERTY OWNER TO SURVEY AND MARK THE PROPERTY LINES FOR A POSSIBLE FUTURE FENCE BUILD. MONUMENTS FOUND AND HELD ARE NOTED. AS SHOWN THERE ARE UTILITY EASEMENTS ALONG THE EAST, WEST, AND SOUTH PROPERTY LINES PER THE ORIGINAL PLAT OF YOUNG'S 2ND ADDITION. AS NOTED AND SHOWN THE FOUND MONUMENTS ARE IN FAIR AGREEMENT WITH THE ORIGINAL PLAT MEASUREMENTS.

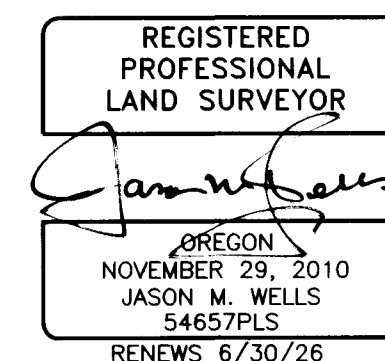
THIS SURVEY WAS MADE WITH A ONE PERSON CREW USING A LECIA GS14 RTK GPS RECEIVER OPERATED OVER THE OREGON REALTIME GNSS NETWORK. CONTROLLING TIES AND MONUMENTS SET WERE VERIFIED BY MULTIPLE OBSERVATIONS.



NOTE:

FOUND DRILL HOLE IN CONCRETE DRIVEWAY. THE PROPERTY OWNER STATED THAT A "SURVEYOR" MARKED THIS LOCATION FOR HIM AND HE KNEW HIS DRIVEWAY WAS ENCRANCHING ONTO THE PROPERTY TO THE EAST. NO RECORD OF SURVEY FOUND. THIS POSITION FALLS 0.18' WESTERLY OF WHERE I WOULD PLACE IT BASED ON FOUND MONUMENTS AND CALCULATIONS PER THIS SURVEY. I HELD THE DRILL HOLE FOR ALIGNMENT OF THE NORTHERLY PROPERTY LINE AS SHOWN IN THE DETAIL. THE TRUE CORNER POSITION IS 0.18' EASTERLY AT THE RECORD DISTANCE FROM THE SET MONUMENT TO THE EAST. I FILLED THE DRILL HOLE WITH LEAD AND ATTACHED A 3/4" BRASS WASHER AS A WITNESS CORNER TO THE TRUE CORNER.
