

OREGON CORNER RESTORATION FORM

Section 23,24,25,26 Township 4N Range 37E W.M.
County Umatilla Date 8/1/93
CORNER DESIGNATION: R-21

Previous Renewals/Surveys, etc. The original survey was made by George S. Pershin under contract No.332, dated July 29th, 1879. He set a basalt stone 18 x 12 x 5 on steep N. side of spur, for Cor. to Secs. 23,24,25 & 26.

A fir, 18 ins. diam. brs. S.18°E., 335 lks.dist.

A fir, 22 ins. diam. brs. S.86°W., 380 lks. dist.

It was resurveyed by Charles L. & William C. Campbell under contract No. 733, dated March 22, 1901. They found a basalt stone 18 x 12 x 5 loosely set on a steep N. slope, from which a fir stump 22 ins. diam.brs. S.86°W. marked as described by the Surveyor General.

He set a basalt stone 18 x 12 x 5 1/2 ins in the ground for cor. of secs. 23,24,25 & 26 marked with 2 notches on the S. and 1 notch on the E. edges. From which a mound of stones, with a 3 ft. base 2 ft. high brs N. 10 lks.

A BO on a ledge 3 x 2 x 1 ft. above ground brs. S.60°W., 18 lks. dist. Hambleton searched for this corner in 1977 but did not find it (map No. N-65).

Monument(s) & Accessories Found: (Condition and Source) Found the remains of a rock mound and a X BO ledge 3 x 2 x 1 ft. on the steep N. slope of spur. Could not find the corner stone.

Monument Set (Procedures and Description): Set a 1 1/2" x 30" iron pipe with a 2 1/2" brass cap marked as indicated in the monument detail 20" in the ground with a mound of stone to the top, N.60°E., 11.9 ft. from the X BO ledge, the rock mound brs. N.5°E., 6.6 ft.
