CORNER DESIGNATION: K-1 Washington Mile Post 35 for Section 13, Township 6 North, Range 36E, and Section 18, Township 6 North, Range 37E, W.M. - Washington

PREVIOUS RENEWALS/SURVEYS ETC:

Originally surveyed by Daniel Major in 1864, his notes state "Made excavation 4 ft. deep, deposited cows head, a quantity of bones some charred stakes and a glass bottle. Planted a heavy seasoned cottonwood post 9½ feet long and 15" diam., top beveled, sides trimmed, ground end charred, marked in deeply cut characters on North face "W" on South face "O" on the East "46L1864" and the West "35M." Mound eight ft. square and 4½ ft. high, well packed and planted with seed."

MOUNUMENT AND ACCESSORIES FOUND:

Found a 2" iron pipe with a large stone alongside, 10" below surface, 1362 ft. west of the found brass cap in Foster Road, marking the West 1/16 corner on the South line of Section 18, Washington. I have accepted the 2" pipe as the evidence of the perpetuation of Mile Marker 35 and the corner common to Townships 36 and 37, Range 6 North on the Washington side of the state boundary.

MOUNUMENT AND ACCESSORIES SET:

At the position of the found 2" pipe set a 1½" x 30" galvanized iron pipe with a 2½" brass cap, 15" below the surface from which:

A silver "DEEP-1" magnet and bearing sign buried 20" bears N. 45° E., 10.00 ft.

A pink "DEEP-1" magnet and bearing sign buried 20" bears S. 45° E., 10.00 ft.

A blue "DEEP-1" magnet and bearing sign buried 20" bears S. 45° W., 10.00 ft.

An Orange "DEEP-1" magnet and bearing sign buried 20" bears N. 45° W., 10.00 ft.

LOCATION AND COMMENTS:

Bearings taken with Silva hand compass and distances measured with a steel tape.

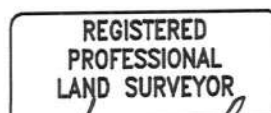
